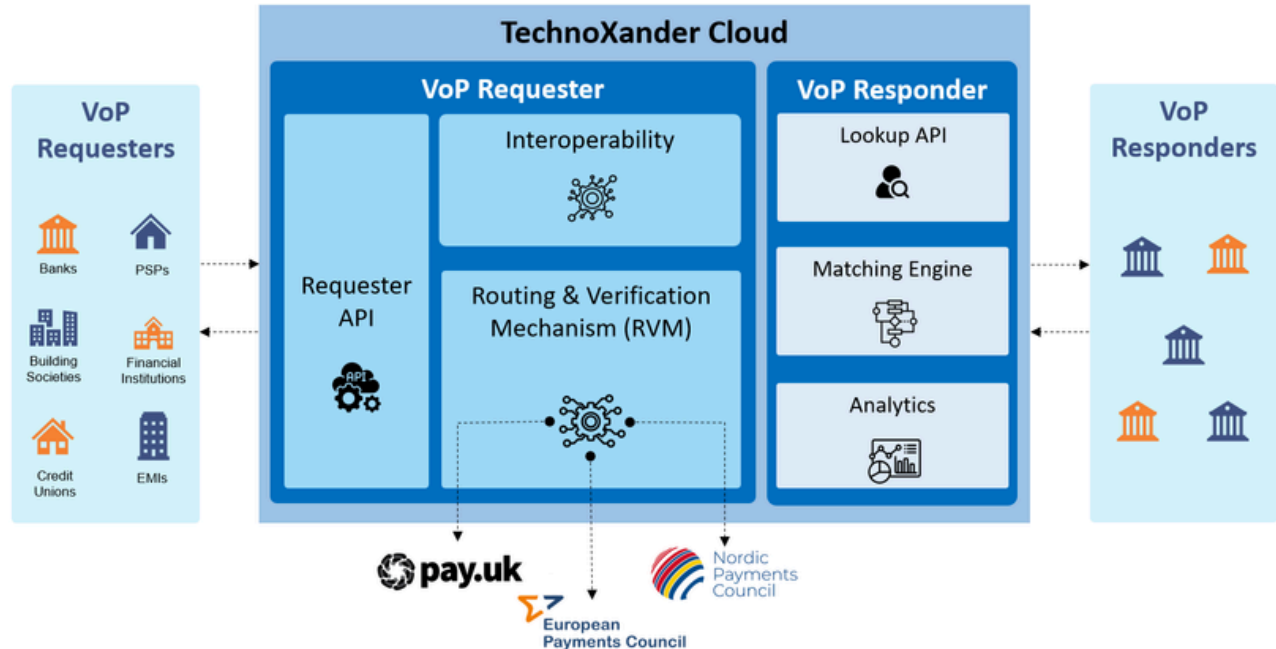
# Introduction

Addressing these concerns, European regulation now expects Financial Institutions in Europe to implement Verification of Payee. Consequently, the **European Payment Council (EPC)** has introduced **Verification of Payee (VoP)** guidelines to help safeguard online financial transactions in SEPA Instant scheme.

**TechnoXander's** innovative **Verification of Payee (VoP)** solution is designed for institutions aiming to fully comply with **IPR and EPC guidelines** while proactively preventing APP fraud as they implement instant payments. The VoP solution is fully compliant with standards set by the **European Payment Council (EPC)**, **Nordic Payment Council (NPC)**, and **Pay.UK (CoP)**, making it a robust choice for banks and payment service providers across Europe.

## Key Components

### Requester API

VoP Requesting Financial Institution engages with this API to commence VoP check ahead of initiating transaction. It allows them to send VoP check request and receive verification response in real-time.

### Routing & Verification Mechanism (RVM)

TechnoXander RVM engine is connected with 5000+ institutions in Europe and UK alone. This engine will successfully identify the most optimised path to receive VoP check response quickly.

### Interoperability

The system supports interoperability with other RVM providers as well as aligns with EPC, NPC and Pay.UK schemes for seamless integration with different payment networks and systems. Interoperability and adherence to standards allows system to communicate with 5000+ institutions without glitches.

### Lookup API

Financial Institutions looking to engage TechnoXander's VoP Responding capabilities will integrate with Lookup API so payee verification can be done in real time. This gives Institutions the capability of opening accounts in their core systems and enabling VoP check on the newly opened accounts at the same time.

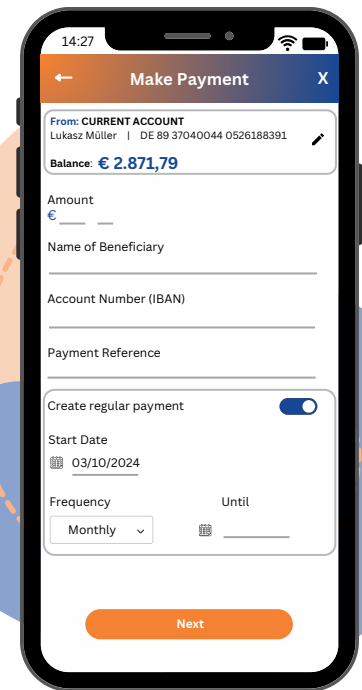
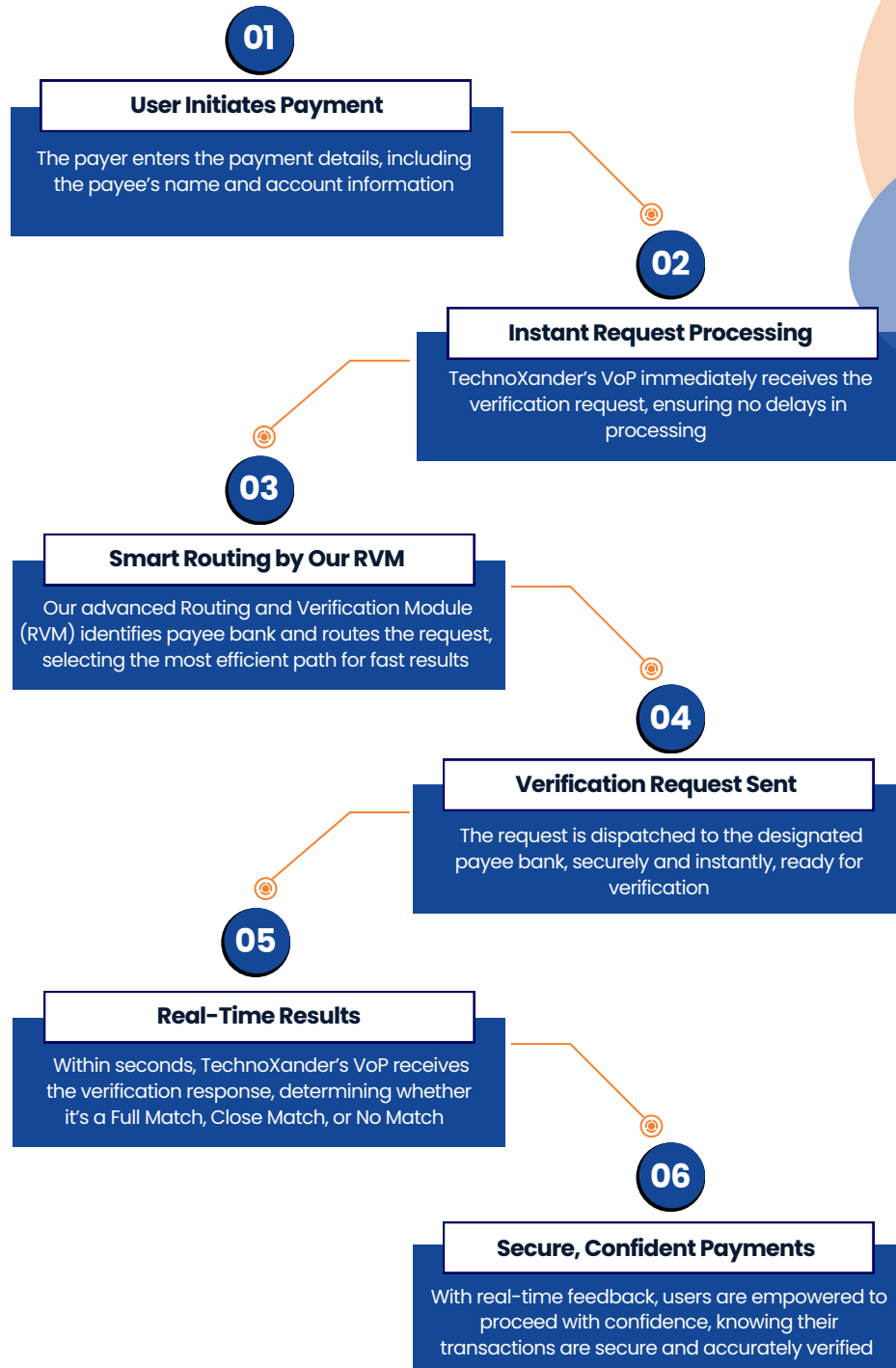
### Matching Engine

The engine uses advanced algorithms for payee verification taking into account cultural differences, diacritics, abbreviations, variations, or misspellings to provide name matching results as full match, no match, close match or match not possible. Name matching is in line with recommendations by EPC, NPC and Pay.UK so compliance is not compromised.

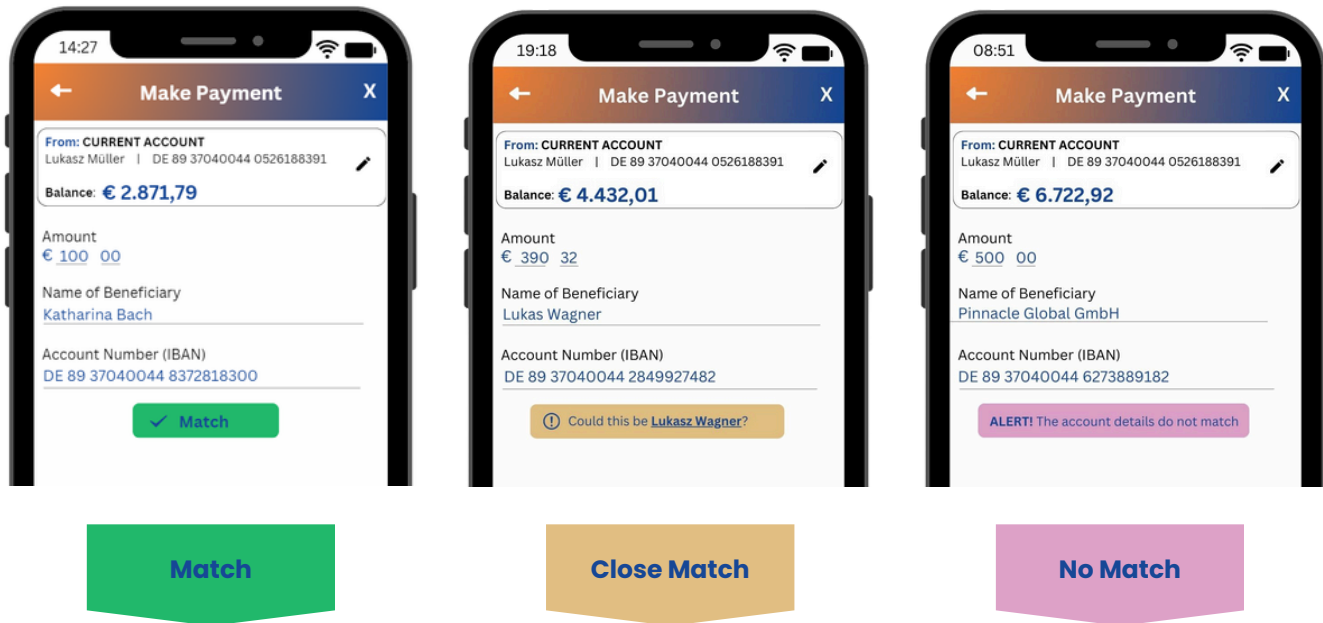
### Analytics

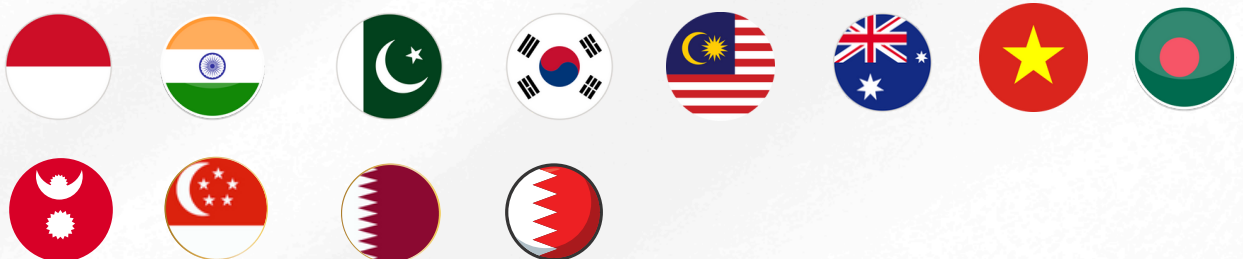
